

# Sports X Competition Participant Injury Waiver and Risk Acknowledgement

## 1. Sports X Insurance

Sports X maintains public liability insurance in connection with the operation of its competitions and activities.

Sports X's public liability insurance is intended to provide cover for certain claims made against Sports X. It is not personal accident or personal injury insurance for individual players.

## 2. Personal Injury and Accident Insurance

Participation in football involves inherent risks, including, but not limited to, sprains, strains, muscular injuries, fractures, dislocations, collisions, falls, concussion, head injuries and other physical injuries.

Sports X does not provide personal accident or personal injury insurance for players participating in its competitions.

Players who wish to have personal accident, sports injury or other personal injury insurance are responsible for obtaining their own appropriate insurance before participating.

Players should not assume that Sports X's public liability insurance provides them with personal injury or accident cover.

## 3. Assumption of Risk

By participating in a Sports X competition, players acknowledge that they understand the physical nature of football and voluntarily accept the inherent risks associated with participation.

Players are responsible for ensuring that they are physically capable of participating safely and should seek appropriate medical advice where necessary.

## 4. Team Registration

The Team Representative is responsible for ensuring that all players registered to their team are made aware of these terms before participating in the competition.

By registering a team, the Team Representative acknowledges that:

- Sports X does not provide personal accident or personal injury insurance for players.

- Sports X recommends that players obtain their own appropriate personal accident or sports injury insurance if they want such cover.
- Participation in football involves inherent risks of injury.
- Players participate voluntarily and at their own risk, subject to any rights and protections that cannot legally be excluded.

## **5. Release and Limitation of Liability**

To the maximum extent permitted by law, participants release and hold harmless Sports X Group, its owners, directors, employees, contractors, coaches, officials and representatives from claims arising from personal injury, illness, loss or damage suffered in connection with participation in the competition, except to the extent that such liability cannot lawfully be excluded, limited or released.

Nothing in these terms is intended to exclude, restrict or modify any right, guarantee, warranty, condition or liability that cannot legally be excluded, restricted or modified under applicable law.

## **6. Medical Treatment**

In the event of an injury or medical emergency, Sports X or its representatives may arrange or facilitate appropriate first aid or emergency medical assistance where reasonably necessary.

Participants acknowledge that Sports X is not responsible for the costs of medical treatment, ambulance services, hospital treatment, rehabilitation or other medical expenses incurred by a participant, except where Sports X is legally responsible for those costs.

## **7. Acceptance of These Terms**

The Team Representative's acceptance of these terms during the Sports X online registration process constitutes acknowledgement that they have read, understood and agreed to this Waiver and Risk Acknowledgement on behalf of themselves and the players they register, subject to applicable law.
